## General Landscape

1. Solar thermal power in Spain generated 4,695 GWh in 2023, an increase of 13.9% over the previous year. It represents 2% of national electricity generation
2. Offshore wind energy recorded record activity in the previous year, representing an 11-fold increase between 2022 and 2023.
3. Solar photovoltaic, thermoelectric and wind energy reach records for the month of January in 2024. The Iberian market experienced growth of 2.1% in Spain and 6.8% in Portugal.
4. Photovoltaic Solar Energy is already the generation source with the highest installed power in Spain
5. Blended financing offers a solution that can help alleviate technological and market risks, key to scaling up small-scale solar projects
6. The EIB and Kutxabank will allocate 600 million in financing to support energy efficiency projects
7. The perfect circumstances are occurring for the battery "boom" to begin in Spain and Europe
8. Naturgy multiplies the capacity of its network by five to distribute renewable gas to more than 70,000 homes
9. Renewable gases seek their place in the energy transition and reduce dependence on fossil fuels from abroad.
10. Naturgy invested EUR 450 million in 2023 for the digitalization and improvement of its network in Spain, 59% more than the previous year.
